

Meadowlake Doggie Daycare & Group Play Guidelines

These guidelines are meant to keep all pets happy, healthy, and safe. These guidelines allow us to provide a positive social environment for your pet at all times.



- To participate in daycare or group play, all dogs must be:
 - At least six (6) months old
 - Spayed or neutered (at least 30 days prior to participation in daycare)
 - Current on all vaccinations (administered by a licensed veterinarian)
 - On effective flea and tick preventative treatment
 - Able to respond to our staff at all times (i.e. basic commands and directions)
 - Not aggressive, dominant, or fearful
- The following vaccinations are required and must be maintained current after the initial series of puppy boosters:
 - **Rabies:** Annual or 3-yr, based on specific documentation by your veterinarian.
 - **DHPP:** 1-yr booster at age 1; every 3 years thereafter.
 - **Bordetella (Canine Cough):** Every 6 months.
 - All vaccinations must be administered by a licensed, accredited veterinarian.
- Pets that pass their daycare evaluation are approved for Doggie Daycare and Group Play. All pets that are approved are *always* considered “on probation” since their behavior can change from day to day. If their social skills become unsuitable at any time, their daycare and or group play privileges may be suspended.
- Since our playgroups are limited in size, advanced reservations are *always* required for pets to participate in daycare.
 - You can guarantee a spot in your favorite play group with a standing reservation.
 - Or individual daily reservations can be made in advance by contacting our facility during regular business hours.
 - Walk in’s or same day reservations are not encouraged and may not be available.
- Pets who have not participated in Doggie Daycare or Group Play for over 3 months will be re-introduced to the pack and monitored closely for any behavioral changes.
 - If their behavior has changed such that it imposes a safety risk to other pets or themselves, they may have their privileges suspended.
 - If your pet has not participated in Doggie Daycare or Group Play for over 6 months, then your pet will need a re-evaluation.

Pets will enjoy approximately 6 hours of play time in Doggie Daycare each day, depending upon when they arrive and depart. Pets are given the opportunity to rest for 2 hours at mid-day in accordance with the dog daycare guidelines of the Pet Care Services Association.

Owner Agreement

By submitting this Daycare Evaluation Application, I am requesting that the staff of Meadowlake Pet Resort evaluate and determine, in its sole judgment, whether my pet may be suitable for participating in the daycare program and/or other social programs hosted by Meadowlake. I understand and hereby agree that:

1. I recognize that there is an inherent risk of injury, illness or death in any environment associated with numerous pets. I also recognize that such risks include, without limitation:
 - a. Injuries, usually benign, such as broken nails, sore paw pads, puncture wounds, abrasions and cuts, particularly in shorter coated breeds, etc.
 - b. Transfer of a communicable illness such as, "canine cough" also known as the Bordetella Virus, or "puppy warts" also known as the Canine Papilloma Virus.
 - c. Illnesses or death resulting from stress, altercations, rough play, or contagious diseases.
2. I understand that Meadowlake cannot be held responsible for any injury, illness, death or damage caused by my pet and that I am solely responsible.
3. I understand that I am solely responsible for any harm or injury caused by my pet to human(s) or animal(s) and I expressly agree to be held responsible for medical costs due to injuries caused by my pet.
4. I am fully aware of the daycare fees and agree to pay in full as agreed.
5. I represent that my pet is:
 - a. In all respects healthy and has received all required vaccinations
 - b. Does not currently have and has not had within prior to 30 days, any communicable diseases
 - c. Is on flea and tick preventative
 - d. Does not suffer from any disability, illness, or condition which could affect it, other pets, or employee safety at Meadowlake.
6. I understand and agree that if any problem develops while my dog is on the Meadowlake campus, my pet will be treated as deemed best by Meadowlake's owner, employees, and agents *in their sole discretion*, and that I assume full financial responsibility for any and all expenses involved.
7. I agree to provide proof of required vaccinations for each dog prior to expiring.
8. I expressly agree to be held responsible for any damage to property (i.e., lodging area, fencing, walls, flooring, etc.) or other costs incurred by my pet.
9. I understand that if my dog displays aggressive behavior, that for the safety and health of my dog and others, he/she will be confined to an enclosure.
10. I understand that "pet" may refer to one or more than one pet.

I REPRESENT THAT I HAVE MADE FULL DISCLOSURE AND HAVE READ, UNDERSTAND, AND ACCEPT THE TERMS AND CONDITIONS STATED IN THIS AGREEMENT, AND ACKNOWLEDGE THAT THIS AGREEMENT SHALL BE EFFECTIVE AND BINDING UPON THE PARTIES AND THEIR RESPECTIVE SUCCESSORS AND ASSIGNS.
